AMRPE ROLE & MEMBER ROLES

By Tom Livers, AMRPE President AMRPE is busy preparing for the 2025 legislative session. Between our Legislative Committee and our contracted lobbyist, we've been closely following discussions of key committees such as the State Administration and Veterans' Affairs (SAVA) regarding interim analyses and potential legislation impacting retirees and pensions. We are the only organization dedicated solely to retired Montana public employees and the issues that directly affect them.

We also coordinate our legislative efforts with organizations such as AARP whose interests typically coincide with those of AMRPE members.

We'll keep you posted on draft legislation as it takes shape and is introduced through updates to our website and targeted announcements, as needed. For major legislation, we may ask you as AMRPE members to directly contact your local legislators to help convey our support or concerns. Hearing from constituents is often the most effective path for helping legislators understand and appreciate potential impacts.

Important legislative decisions may happen quickly given the pace and deadlines of the 90day session. We'll work to summarize key issues and bills to help you stay informed to be ready when quick action is needed. Thanks in advance for your help in working together in the coming legislative session.

POTENTIAL 2025 LEGISLATION

State Administration & Veterans' Affairs' proposed bills

- LC 0225 increase PERS, SRS, HPORS & GWPORS employer contributions by 0.1% each year for 10 years (*PERB supports*).
- LC 0226 return SRS & HPORS retirement requirement to 20 years of service OR age 50. Would repeal legislation passed in 2023. (*PERB is informational*).
- LC 0227 repeal the use of layered amortization for SRS, HPORS, GWPORS & JRS actuarial valuations (*PERB supports*).

Public Employees' Retirement Board's proposed general revisions bill

 LC 0267 – Duty-related disability benefits in public safety systems will not convert to service retirement benefits and are not subject to federal taxation.

Legislators' Proposed Bills to Date (check bill information link for later bills)

- LC 0020 Capping the Actuarily Determined Employer Contribution decrease at 0.5%, same as the current 0.5% cap on contribution increases.
- Other bills go to Legislative Website "look up bill information" and search subject "retirement."
